2010.27 Public Participation. None.

2010.28 Progress Reports.

- 2010.28.1 Waste Recycling Facilities at Allerton Quarry (minute 2010.4 refers). This matter was discussed at the Annual Parish Meeting earlier in the evening and no further discussion took place.
- 2010.28.2 Harrogate Rural Safety Scheme fund (minute 2010.5.1 refers). Correspondence from NYCC regarding the £3,000 allocated to the Parish Council under this scheme was noted and it was agreed that in view of the fact that alternative projects were not now being allowed, the Parish Council would request that the original plan of installing a Vehicle Activated Sign should go ahead.
- 2010.28.3 Grasscutting (minute 2010.5.2 refers). The Chairman agreed to obtain some quotes.
- 2010.28.4 New Bench Seats (minute 2010.5.3 refers). It was noted that at the Annual Parish Meeting the overwhelming majority of people were in favour of the proposal to install a bench seat at The Mar, and it was agreed that the Clerk should press ahead with this. Cllr Houseman and the Clerk to liaise regarding the installation.
