Development of a Waste Recovery Park (Allerton Waste Recovery Park - AWRP) at Allerton Park Quarry, near Knaresborough comprising the erection and operation of a Tipping Hall (TH); a Mechanical Treatment (MT) facility; an Anaerobic Digestion (AD) facility; an Incinerator Bottom Ash (IBA) Processing, Production and Storage facility; a unit housing six Air-Cooled Condensers and an Energy from Waste (EfW) facility to generate electricity.
