# Minutes of the Parish Council Meeting held on Wednesday 14<sup>th</sup> January 2015 At 7.30pm in Arkendale Community Hall

**2014.75** Public Participation – Cllr Topham welcomed the members of the public

2014.76 Minutes of the Previous Meeting

The minutes of the meeting held on 19<sup>th</sup> November 2014 were approved as a correct record and signed by the Chairman.

#### 2014.77 Reports from other Councillors

Cllr Windass reported on matters from NYCC

**Buses** – Eddie Brown no longer running the local bus services. These have been taken over by another provider and Cllr Windass provided a copy of the latest timetable. No further information on whether the routes or frequency will change

Potholes – NYCC have been given an amount by central government to repair the roads

NYCC budget – there are still issues regarding cuts and shortfalls

CIL – to replace S.106 agreements. Harrogate likely to adopt 2015/16

Cllr Alton reported on matters from HBC

**HBC budget** – finances are in good order. No increase in council tax for 2015/16

**Housing** – consultants have been looking at the number of houses required in the Harrogate area and are likely to report that the requirement will be significantly less than originally forecast by the government inspector.

**Local development plan** – will be finalised by 2017/18

Cllr Topham thanked both Councillors for their reports and it was agreed that they would stay and respond to queries after the presentation by Skelwith

#### 2014.78 Flaxby Golf Course Development

Presentation of plans by Ben Pilgrim on behalf of Skelwith Group

Members of the public raised concerns regarding planning procedure, size and density of the development, the size of the roundabout, sustainability in terms of education and road infrastructure, how it will impact on the local development plan and the timing of the project. Ben Pilgrim emphasised that the project is still at a very early stage and that many details have not yet been agreed – however a planning application will be made in the next 3 months. Cllr Alton confirmed that whilst HBC have a duty to respond in 16 weeks, it will be months before the planning application goes before committee due to the level of detail and investigation which will be required.

#### 2014.79 The Bluebell

Cllr Shipman reported that there is an open invitation to view the site and that the works are on schedule to complete before Easter.

- 2. Application 6.78.92.B.FUL demolition of 2 outbuildings, erection of garage, log store and garden store, alterations to front wall and formation of new access road and hardstanding to include access steps at Dale Farm, Arkendale permission granted subject to conditions
- 3. Application 6.78.93.PBR change of use of agricultural building to 2 dwelling houses at Holgate Farm, Arkendale permission granted subject to conditions
- 4. Application 6.87.33.BPDUCO installation of 2 rooflights at The Granary, Clareton Lane Coneythorpe permission granted subject to conditions

- Application 6.87.38.C.FUL erection of pitched roof over existing flat roof to form additional living accommodation and erection of detached double garage (revised scheme) at Bramblewick, Shortsill Lane, Coneythorpe – PC has no objections
