2015.23 Apologies for Absence – Alan Stokes and Gavin Holman

2015.24 Declarations of Interest - none

2015.25 Public Participation – Cllr Topham welcomed members of the public

2015.26 Minutes of the previous meeting:

The Minutes of the meetings held on 27th May 2015 (AGM, OPC and APC) were approved as correct records and signed by the Chairman

2015.27 Reports from other Councillors

Cllr Windass reported on matters from NYCC

- **Devolution** there is currently discussion on various permutations
- **Boundary Commission** it has been confirmed that the current County divisions are acceptable
- AWRP there is a dispute on what was agreed with local residents. There will be a meeting next week.
- Broadband more funding has been allocated across North Yorkshire
- Bus services cutbacks to services to go ahead. It may be that individual bus companies devise their own routes
- Reintroduction of County Councillor's allowance this is a £5000 allowance which can be allocated to community projects with a minimum of £300 and a maximum of £5000. Cllr Windass invited proposals for consideration.
- Highways nothing new to report

Cllr Alton reported on matters from HBC

- Cllr Alton announced his retirement for next May.
- Local plan consultation has now finished and a new local plan is due 2017. No

planning application has been received from Skelwith as yet. HBC now has a 5 year housing plan

- Harrogate Town Centre consultation has now been carried out
- Knapping Mount now vacated. All staff have been moved to existing accommodation leading to some very cramped conditions until the new accommodation is available.
- **Boundary Commission** ward boundaries in the Harrogate district are being decided.

2015.28 Report from PC Sue Brookes (Knaresborough Police Station)

- PC Sue Brookes confirmed her retirement. She will be replaced by PC Tim Craven (tim.craven@northyorkshire.pnn.police.uk) on 1st November.
- A concern was raised regarding the speed of cars on Moor Lane. PC Brookes advised
 that the Fire Brigade will monitor speeds and then provide analysis and that she will
 send the forms to the clerk. If the analysis has already been done then it cannot be
 repeated for another 3 years (re Coneythorpe even though there was a query
 regarding whether it was measured at the best place).

2015.29 Proposed Defibrillator

• John Brook gave a short presentation on the merits of a defibrillator and how it works. The cost would be in the region of £1200. John agreed, at the request of the Council, to organise a training event on CPR in the first instance. This could be arranged at no extra cost. Cllr Topham and John Brook to organise a suitable date and discuss ways of advertising the event.

Cllr Shipman reported on the following planning matters

- Application 6.78.93.A.FUL retention of vehicular access and wall at Holgate Bridge Farm, Moor Lane, Arkendale – planning permission granted subject to conditions
- Tree Preservation Order 56/2014 land comprising OS field 3077, Shortsill Lane, Coneythorpe – it was determined not to confirm the Order
- Application 6.78.7.I.FUL erection of two storey extension and alterations to fenestration at 22 Manor Park, Arkendale – planning permission granted subject to conditions
- Application 6.78.49.D.FUL erection of garage extension at Dale Farm Cottage, Moor Lane, Arkendale planning permission granted subject to conditions
- Application 6.78.67.E.DVCON variation of Condition 2 (approved plans) of planning permission 6.78.67.D.FUL to allow for reduction in size of kitchen extension at Pond House Farm, Arkendale – permission granted subject to conditions

- Application 6.78.49.D.FUL 15/02414/FUL erection of garage extension at Dale Farm cottage, Moor Lane, Arkendale – Parish council has no objections
- Application 6.78.89.A.FUL 15/01941/FUL erection of five dwellings with associated formation
 of vehicular access, parking and landscaping at land comprising field west of Long Acre, Moor
 Lane, Arkendale Parish Council does not object to or support the application but wishes to
 make the comments or seek safeguards as set out in out in the letter attached to the response
- Application 6.87.16.G.FUL 15/02717/FUL erection of porch, single storey, two storey and
 first floor extensions and replacement roofs, alterations to roofs and chimneys to include
 conversion of loft to form additional living accommodation, alterations to fenestration,
 demolition of existing conservatory and installation of septic tank at Clareton Farm, Clareton
 Lane, Coneythorpe. Cllr Shipman queried whether any decision has been received. Clerk
 to chase HBC.
- Letter dated 7th August 2015 from the PC to Oliver Quarmby approving the move of the phone box in Arkendale
- Application 6.78.89.A.FUL 15/01941/FUL Erection of 5 dwellings at field west of Long acre, Moor Lane, Arkendale Cllr Shipman reported that the application will not be taken forward in it's current form because more detail is required and the applicant, Mr Milner, has not initiated any prior discussion with the planners which would be normally be required. Furthermore, there is only scope for a limited amount of development within the field within the boundary of the village and proper screening would be required. If

revised plans are submitted then the Parish Council will have an opportunity to comment.

 Application 6.78.18.F.FUL 14/04505/FUL – conversion of barn to form two dwellings with associated parking at The Barn, Moor Lane, Arkendale - Cllr Shipman reported that the original application is invalid but it will shortly be reinstated and the Parish council will have an opportunity to comment.

Cllr Shipman confirmed that the benches have been ordered and that Brian shipman will oversee installation as both benches need to be securely fixed in place. Clerk to liaise with Sean Wright. HBC Housing has granted permission for the bench to be located on Clare How Close
- Coneythorpe village sign Cllr Topham reported that the matter is on hold at present due to difficulties in sourcing suppliers. He will raise the matter at the Village AGM to assess interest.

- Speed restrictions Cllr Robertshaw referred to a letter from 95 Alive dated 23rd June 2015 which confirmed that (with few exceptions) the speed restrictions were being adhered to. There was a query regarding the positioning of the monitoring device but the rationale for the positioning was explained by 95 Alive. No further monitoring can take place for three years
- Ivy cottage and The Old Forge Clerk confirmed that no further action is being taken by HBC at present.
- Coneythorpe website Clerk confirmed that there is a link on the Arkendale website ready for use but as yet no further action has been taken
