Minutes of the Ordinary Parish Council Meeting held on Tuesday 23rd March 2021 via Zoom

2020.92 Minutes of the Previous Meeting

The minutes of the Ordinary Parish Council Meeting held on Tuesday 18th August 2020 were approved as a correct record and signed by the Chairman.

2020.93 Reports from County and Borough Councillors

Cllr Metcalfe and Cllr Windass discussed the introduction of a Unitary Authority to replace the current structure. The options being considered are either NYCC only or an East and West division. Cllr Metcalfe and Cllr Windass are in support of the NYCC option due to performance and cost savings.

Cllr Windass advised that the only election to take place this year will be for the Police, Fire and Crime Commissioner in May. Other elections are now postponed until 2022.

Cllr Windass provided an update on Coronavirus advising that NYCC has now recorded 1000 deaths. He explained that the Coronavirus pandemic has had a large financial impact and future cuts are inevitable.

Cllr Windass advised that winter has taken its toll on the highways and work is underway to make the required improvements.

Cllr Windass also provided an update on the proposal for motorway services at Kirby Hill. A three-week inquiry has now taken place and a decision is expected by July.

Holgate Bridge - Cllr Robertshaw advised that the fencing is collapsing which requires repair and there is some plastic fencing which needs collecting. Cllr Robertshaw is chasing Area 6.

2020.97 Countryside Matters and Fly Tipping

Cllr Houseman reported two fly tipping incidents, one incident was a mattress and the other was several bags of builder's rubble. The council were notified, and the items were removed promptly.

Cllr Houseman advised that there have also been minor fly-tipping incidents which he has resolved locally.

2020.98 Village Reports

Arkendale

- Community Hall is planning to re-open partially from 17th May 2021
- The Church is re-opening on Sunday 4th April 2021 for Holy Communion, following this the Church will be open until 4pm and there will be an Easter raffle to raise funds for the Church.

- Notice Board Cllr Houseman arranged for the notice board to be repaired, however it was found to be beyond repair and therefore a new one will be installed.
- Village Pump Cllr Mullen is looking for volunteers to tidy up the area around the village pump and bench
- Church Lights the Church were not aware of any problem with the lights but are investigating

Coneythorpe and Clareton

- Clareton village sign Cllr West advised that the cost per sign is approx. £400 including installation. Cllr West is to consult with Clareton residents.
- Defibrillator for Coneythorpe Cllr West advised we have received £1000 grant and The Tiger Inn has agreed to pay for any additional costs. Due to the fire at The Tiger Inn it is currently not possible to install the defibrillator, Cllr West is to take delivery and hold the machine until it can be installed.
- Potholes Cllr West advised there is a query around ownership of a section of Green Lane, Cllr West and Cllr Quarmby are to follow this up.
- Millennium Bench Cllr West advised that required repairs have been made and the bench is back in place.
