2021.29 Highways

Holgate Bridge - Cllr Robertshaw advised that he is continuing to chase Area 6 to action the repair.

Cllr Robertshaw advised that a car has collided with a 30mph sign in Coneythorpe, the sign now requires replacing and this has been reported to Area 6 for action.

2021.30 Countryside Matters and Fly Tipping

Cllr Houseman advised that there have been no new incidents of fly tipping since the previous meeting.

2021.31 Village Reports

Arkendale

- Speeding through the village Cllr Quarmby provided an update that a second speed survey has been completed since the previous meeting. The results were similar to those of the first survey and also concluded that the village does not have a speeding problem. As a result of these additional readings, NYCC have confirmed that they currently will neither support nor fund any speeding intervention. Cllr West agreed to provide a copy of the results to David Cox after he raised concerns over their validity. There was a discussion amongst Councillors and members of the public surrounding ideas to slow traffic through the village, however, it was concluded that this would not be a good use of public funds due to the results of the surveys.
- Non-local tractors and HGVs coming through the village David Cox advised that there is a problem
 with non-local tractors regularly passing through the village. Cllr Houseman advised that some
 tractors, although may not appear local, could be contractors visiting local farms or land surrounding
 the village. He also advised that the tractors are carrying out seasonal work in the fields and this will
 become much quieter in the coming months. Cllr Robertshaw advised David Cox that if he provides
 details of any tractors he suspects should not be passing through the village, he will pass this on to
 Trading Standards.

Coneythorpe and Clareton

- Clareton village sign Cllr West advised that the two signs have now been installed at a total cost of £413.23.
- Defibrillator for Coneythorpe Cllr West advised installation is scheduled to take place by 25th October and he is looking into options for training.
- Potholes Cllr West advised that a further report has been submitted requesting gravel and not tarmac which has been proposed.

2021.32 Correspondence Received

Cllr Robertshaw advised that he had received a compliant regarding PPE/waste left behind following waste collections, this has been reported to HBC.

Cllr Mullen advised this is to be carried onto the next agenda.

Cllr West and Gavin Holman are progressing this and will provide an update at the next meeting.

2021.36 The Mar / Tree and Hedge Project

The Mar - Cllr Quarmby advised that we are chasing for the Land Registry for completion.

Tree and Hedge Project - 63 trees were originally planted in total, 8 of which were immediately removed by a neighbouring landowner who objected to their location, which left 55 in place. 9 on private land and 46 on public land. Cllr's Mullen and Quarmby conducted an inspection of the 46 public trees in July 2021 in line with the Parish Council's risk assessment policy and insurance. In summary; 9 appear to have been cut down during hedge cutting, 16 are healthy and 21 are dead. They have presented a proposal to utilise the remaining grant funds to replace some of the unsuccessful trees and are currently in process of gathering quotations which will be presented at the next meeting.

2021.37 Internal Audit Findings

Cllr Mullen advised that two actions highlighted in our recent internal audit were the GOV.UK website which is currently being actioned by Cllr West and Gavin Holman as above, and a review of the Complaints Procedure which Cllr Mullen has agreed to action.

2021.38 Commuted Funds

Cllr's Mullen and Quarmby presented the Commuted Sums available as at April 2021 which were supplied by HBC. Summary below:
