• Chairman's Report

Cllr Quarmby provided this report in the Annual Meeting of the Parish Council.

• Finance Report

Karen Mullen provided a finance report as below.

The Parish Council's costs have been controlled in the year with underspends against budget for; room hire, admin, audit and training.

General reserves have been utilised for road safety investigations and maintenance of the Mar which was previously funded through grants.

The Parish Council retains £3713.90 of restricted reserves that are related to grants:

- £1000 –Coneythorpe Defibrillator
- £2500 Green Lane TOP
- £213.90 Underspend on the Mar / Tree and Hedge Planting

The Parish Council retains £8111.16 general reserves, under the reserves policy the following must be held:

- £3100 representing 1 years budgeted expenditure
- £1000 representing potential liabilities relating to the Mar
- £500 representing a fund for fixed asset replacement
- £1000 representing known commitments of spending for the Clareton village signs and shortfall in funding for the Coneythorpe defibrillator

Free reserves available to fund projects are therefore only £2511.16. The Parish Council reiterated its commitment to identify projects to spend the available funds whilst maintenance the required reserves. Cllr Quarmby requested attendees to consider projects which might be suitable.

P.2022.05 Reports from Other Community Groups

Community Hall – Gavin Holman provided an update as below.

- They are now operating as normal, COVID-19 restrictions have been lifted; however, they are advising visitors to take reasonable precautions through good hygiene and ventilation.
- The cinema is now back monthly and has a full schedule until September with more films to be arranged thereafter.
- The Hall, alongside the Parish Council, are sponsoring some aspects of the Arkendale Jubilee celebrations and an offer has been made for Coneythorpe's event.
- They have carried out maintenance at the hall throughout the year, including replacing the south-facing window surrounds with a more durable treated wood.

- Yoga, Pilates and Zumba classes, together with other regular bookings, are now back to normal and other bookings are also on the increase.
- The Hall are grateful for the COVID-19 relief grants received from HBC to cover operational costs when there was no income.
- Trusted hirers are now provided with their own keys for the hall to reduce the demand on the committee/trustees.
- The Hall have 3 new committee members Sharon Thackray, Lorraine Johnson and Pauline Ward.

Arkendale Church / Parochial Church Council - Robyn Cox provided an update as below.

- The PCC has new members this year and is currently very strong
- They have had to carry out significant fundraising this year due to lack of income from COVID-19
- Maintenance has been carried out throughout the year, including the painting of the railings
- There is an ongoing project to replace the exterior lighting with LED's which has been funded through a grant
- The clock restoration project is still ongoing. They have managed to secure two grants so far (Allerton Waste Recovery Park and Church of England) and they are still looking for more. Their the grants and the 'Sponsor a Numeral' campaign they have raised £3750 so far towards the £7100 that is required. The Parish Council agreed to investigate whether they were able to contribute financially to this project.

Arkendale Women's Institute - Janet Grimes provided an update as below

- They have 17 members currently and are actively looking for new members to join
