- 2023.22 Public Participation. The Chair welcomes all to the meeting.
- **2023.23 Minutes of the Previous Meeting.** Minutes of the Annual Meeting, the Ordinary Parish Council Meeting, and the Annual Parish Meeting held on Wednesday 24<sup>th</sup> May approved and signed by the Chair.
- 2023.24 Reports from other Councillors (North Yorkshire Council)
  - Cllr Robert Windass provided an update following the restructuring at the Council and the boundary change. He has lost some parishes but gained Goldsborough and Burton Leonard.
  - Main concern for Council at present is RAAC. Currently only one school in Scarborough affected.
  - Budget some modest savings made to date this year but started budget planning process for 2024/25 and likely will need to take £30m from reserves.
  - There is currently an issue with recycling collection due to staff shortages.
  - Ofsted report for looked after children was outstanding.
